I agree to provide proof of watercraft liability insurance to the 10,000 Lakes Concours, LLC in advance of the event if requested

I agree to place a fire extinguisher accessible near my watercraft while on display.

I will indemnify, defend and save harmless 2019 10,000 Lakes Concours, its committees, staffs, directors, partners, vendors, volunteers and agents from and against any and all liability, claims, damages, costs and expenses (including reasonable attorney's fees) in connection with my participation in the 10,000 Lakes Concours which results from my negligence.

I acknowledge that the indemnified parties above assume no liability for stolen or damaged property and agree that I display my watercraft at my sole risk, and I waive all claims against the indemnified parties for damages to my boat except those which result from the negligence of an indemnified party.

I give permission and free unconditional non-exclusive license to use my name and images of my watercraft for promotional or educational purposes in connection with the 10,000 Lakes Concours (whether before, at, or after the Concours event).

All provisions of the Agreement & Waiver apply to participation in all events related to the 10,000 Lakes Concours.

I understand that proof of liability insurance will be required upon approval of my entry.

Upon signing this agreement and waiver, I agree to keep my watercraft on the show field until the completion of the show.
